

EVENT WAIVER – MUD MONSTERS RUN 17/05/2026

PARTICIPANT WAIVER, RELEASE OF LIABILITY COVENANT NOT TO SUE & IMAGE RELEASE

In consideration of being allowed to participate in any way in the above referenced Mud Monsters Run competition(s), race(s), related events (the Event) and/or activities,

I, the undersigned, acknowledge, appreciate, and agree that:

1. The Event represents a high-risk and extreme activity of which I accept the risks related to its participation
2. The term Organisers herein means, collectively or not, MUD MONSTERS RUN LIMITED and their officers, directors, representatives, officials, principals, agents and/or employees, subsidiaries, and/or assigns, as well as their independent contractors, sponsoring agencies, sponsors, advertisers, volunteers, and if applicable, owners and lessors of the premises used to conduct the Event.
3. I acknowledge that good physical condition is required in order to participate in the Event. Thereby, I acknowledge it is my sole responsibility not to participate or cease any participation in the Event if I suffer, before or during my participation in the Event of any discomfort or sickness whatsoever for any reason whatsoever. Without any limitation, I acknowledge that it is strongly not recommended and reckless to participate in the Event if I suffered or suffer of any condition, illness or health issues related to: (i) cardiovascular; (ii) pulmonary; (iii) articular; (iv) cerebral; (v) diabetic related or (vi) hematologic.
4. I acknowledge that my participation in the Event represents risks of injury and/or death and that the activities involved in the Event can cause, without limitation, the following: (i) drowning; (ii) near- drowning; (iii) sprains; (iv) strains; (v) fractures; (vi) lesion such caused by fire or heat and cold injuries; (vii) over-use syndrome; (viii) Injuries involving motored or non-motored vehicles; (ix) animal bites and/or stings; (x) contact with poisonous plants; (xi) accidents involving, but not limited to paddling, climbing, hiking, travel by car, or other convenience; (xii) heart attack and (xiii) the potential for permanent paralysis and/or death.
5. I certify that I am eighteen (18) years old or over. In the event whereby the participant is a minor, I confirm, as their parent and/or legal guardian, that the minor participant meets the age criterions required by the Organisers to participate in the Event and commit herein. If the minor is aged 13-15 I can confirm they will be accompanied for the duration of the run either by myself or an adult whom I deem responsible.
6. I accept freely and voluntarily all risks, known or unknown, inherent to my participation in the Event.
7. I consent to administration of first aid and other medical treatment in the event of injury or illness during the Event and hereby release the Organisers from any liability or claim arising out of such treatment.
8. The Organisers have the right, at their sole discretion, to report, cancel or modify the Event because of weather, force majeure or any other reason, without any reimbursement. The Organisers may refuse access in the Event or exclude from the Event, at their sole discretion and for any reasonable motive, any participant in the Event, without any reimbursement.

9. I accept and authorize the Organisers to use, copy and/or broadcast all over the world my image, on any support whatsoever (eg.:pictures, videos, films, or any other), taken during my participation in the event for any reasonable motive such as, without limitation, advertising or promotion, without any time limit and without any compensation. Thereby, I assign all my rights in my image taken during the Event.

10. I acknowledge having chosen to fill and agree with this document.
